New in 2007: Minister/Formation Director Workshops

The long-awaited minister/formation director workshops are about to begin.

Three workshops are planned: Raleigh, N.C., Feb. 3; Greenville, S.C., April 14; and Chattanooga, Tenn., June 23.

These workshops are open to all members of your fraternity's formation team, but we especially want to encourage the minister (or leader) and formation director to attend.

I sent the workshop information and registration form to all ministers and chosen leaders before Christmas. Reminders, directions, and further details will be sent out prior to the workshop you register for.

Cost is \$12 per person. One check can cover everyone on the registration form and should be made payable to BSSF Region. Completed registration forms, with payment, should be sent by Jan. 20 for the Raleigh workshop, by March 24 for the Greenville workshop, and by June 9 for the Chattanooga workshop.

In a previous Communio, an article mentioned the possibility of having an ecology commission component to these workshops. This *will not* take place, but a special ecology session will be held at the Annual Regional Gathering in August.

Each workshop will be essentially the same so you will need to attend only one of them; however, we wanted to make them easily accessible for everyone, which is why we have three locations. The locations of the workshops are in areas that should be no more than a three-hour

Let us pray and reflect how we are called to follow and do what is ours to do this year.

Editor's Journal: Musings on the season

In a recent homily, my pastor, Fr. Frank Doyle, OSA, said that the shepherds were immersed in their vocation—caring for the sheep entrusted to them—when the angels appeared to them to announce Jesus' birth. They then became the first to visit him who would become shepherd of us all; who, lying in a manger—a feeding trough—would become food for the world.

This made me think: Since SFO is supposed to be my way of life, am I always immersed in my Secular Franciscan vocation?

The shepherds were doing what they always did, living their way of life, and in that way of life they were open to hearing what God had to say to them—and to act upon it.

In my way of life, do I always hear what God is saying to me and do I act upon it?

Do I always live fraternity, spirituality, formation, and apostolate?

Fr. Frank has said that people have told him that they hate Christmas because of the commercialism. How sad is that?

But why get caught up in it?
Begin preparing now, in thought at least,

for a materialism-free Christmas 2007. Some suggestions:

Don't receive gifts. How much more stuff do we need? Arrange with those who usually give you presents that you will not give anything to each other. Instead, send a donation (whatever you would have spent on gifts) to Food for the Poor, Catholic Relief Services, or some other organization whose beneficiaries *really* need the contribution.

This cut my shopping to the young children in my family and to a couple of other family members who needed gifts, but even one of them agreed to make a Food for the Poor contribution in lieu of sending me something.

Not receiving gifts is very freeing. It certainly lightened my mood.

Fr. Bob Dueweke, another of the Augustinians in my parish, told me that this past Christmas his family decided not to draw names to exchange gifts with each other. Instead, they "adopted" a home for elderly people who have Alzheimer's and whose families have mostly abandoned them. Fr. Bob's family bought gifts for the people in that home.

Avoid commercials. Yes, it can be done. Instead of watching lots of television once the commercial Christmas season begins (let's see, that's about late September or early October), check your TV listings for only the programs you really, really, really want to see. Watch only those programs, thus reducing the number of commercials you see. This could become a year-round habit.

Even better, if you have the equipment, record the programs (with the set off) and watch the shows later, fast-forwarding through the commercials.

You'll find more satisfying ways to fill your time.

Don't shop during the Christmas season. I love arts-and-crafts shows, and here in the mountains we have a lot of them, especially during the summer. If I see something at one

of these shows that I think someone will like (one of those few people on my list who does need a gift), I buy it then. I find that this dulls the temptation to buy for myself. It also eliminates the necessity—and stress—of shopping in crowded stores during the Christmas rush.

Novenas requested for people of Darfur

Members of the National Fraternity Council of the Secular Franciscan Order met in Marathon, Wisc., Oct. 24-29, for the annual NAFRA gathering.

In addition to the responsibility of electing our executive council, we prepared statements of concern (see below) regarding the tragic situation in Darfur and support of the recent pastoral letter issued jointly by the Catholic bishops of Mexico and the United States regarding immigration. reported in TAU-USA's winter issue.

The following statement on Darfur will be sent to President Bush as well as news media and publications:

"Two years ago in our annual meeting, the National Fraternity of the Secular Franciscan Order, representing over 15,000 members throughout the United States, unanimously adopted a statement condemning the genocide in the Darfur region of the Sudan.

"As that horror continues, this year the National Fraternity reiterates that cry for justice and again urges that the United States firmly support the United Nations peacekeeping efforts in Darfur. In addition, we urge that the United States Immigration and Naturalization Service grant prompt and just refugee status to the people of Darfur now languishing in refugee camps in Kenya and throughout Africa."

The feeling of helplessness led us to propose some additional action to end this crisis. A donation of \$2,000 will be sent to the Catholic Relief Fund for aid to Darfur, and we can raise our 15,000 voices in prayer. A novena will be prayed across the country with each region assigned a time to pray during the year. Please pray the prayer on page 8 for those suffering and for those causing the suffering.

All members of the Brothers and Sisters of St. Francis Region are asked to pray for nine days beginning Feb. 11, and again beginning Aug. 12. **T**

profession in 1981 and was ordained a priest in 1986 in New York. Later, he transferred to the Archdiocese of Atlanta. He served at the cathedral and at the Shrine of the Immaculate Conception in Atlanta and at Prince of Peace Church in Cumming, Ga. He was active in various apostolates and served as Immaculate Conception's spiritual assistant when the fraternity met at Sacred Heart Parish in Atlanta.

Laura, living on the West Coast at the time, had joined a widow-support group that asked Fr. Steve Gross, OFM Conv., to be its chaplain. One Sunday he spoke of the Franciscan Order and the family of Francis. Five members of this group joined with others and after several years of formation, 12 were professed in September 1981 in St. Francis Fraternity in the Province of St. Joseph of Cupertino.

She was elected fraternity minister that November and in February 1982 became province minister, a position she had for nine years. It was an exciting time, with the development of new fraternities and renewal of older ones. During this time she served five years on the first National Formation Committee, which developed *Guidelines for Initial Formation in the United States*

She also served on the regionalization committee that resulted in Secular Franciscans in the United States being grouped in regions instead of being attached to a particular obedience of the First Order. She also served 12 years as a councilor in CIOFS (the International Fraternity of the Secular Franciscan Order).

Since September 2003, Laura has been the chosen the leader of the St. Monica Newly Forming Group in Duluth, Ga., which Immaculate Conception sponsors. **T**

A new meeting place is required as the region has outgrown the Wyndham Garden Hotel in Charlotte. The members discussed possible new locations:

- a. Ridgecrest, a Baptist-owned conference center near Asheville, N.C.—Joanita Nellenbach, SFO, Communio editor; and Pat Cowan, SFO, Area 5 councilor, have visited this site and been very impressed. However, Pat reported that the chapel is not in the same building where the ARG would be held. It was also noted that no alcohol (other than wine for the Eucharist) is allowed on the site. Judy planned to visit also.
- b. Embassy Suites—regarded as too pricey.
- c. Marriott in Spartanburg. Prices were to be sent to Judy.

Judy was to send all REC-CG members a checklist for comparing the various places.

Fr. Linus recommended obtaining a fiveyear contract, if possible, at whatever place is selected, so that we would save money by being locked into a price.

Paula Zanker, SFO, regional formation director, had already sent Judy the proposed agenda and format, which she distributed to the meeting attendees. Cost for the workshop—\$12 or \$15—was discussed.

Registration forms were to go out in late November or early December. Dates for the workshops are Feb. 3, Raleigh, N.C.; April 14, Greenville, S.C.; June 23, Chattanooga, Tenn.

Jim Taylor, SFO, regional ecology commissioner co-chair, asked if he could give a talk during the workshops. The council determined that the best place for the talk will be at the ARG. Jim agreed and will plan for that.

3. NAFRA meeting.

Judy reported on some of the highlights from the NAFRA meeting, held Oct. 24–29 in Wisconsin. A new NAFRA executive council was elected.

A "Novena Prayer for Darfur" (p. 8) was created during the meeting. Each region is assigned time to pray. Our region's time is the second week in February and August of 2007. The prayer will be sent to the local fraternities.

Judy and the BSSF council reviewed the "State of the Order" report from then National Minister Carol Gentile, SFO.

We also reviewed our region's report, generated by the NAFRA visitation at the ARG last August. The biggest concern is the lack of spiritual assistants at the local level. We cannot get approval from all provinces to allow us to have secular spiritual assistants. We are least concerned about our growth in members. We also talked about the requirements for the "Life-Giving Union" course and paperwork involved with it. Joanita will work with Fr. Linus to coordinate efforts to get all the papers together and to work with the provinces to get a program started.

4. Merging community

St. Benedict the Moor Emerging Community, Macon, Ga., wishes to stop the process of becoming a fraternity and, instead, merge with Immaculate Conception Fraternity, Jonesboro, Ga. Cricket made a motion, seconded by Deacon Dennis Arcand, SFO, that the emerging community merge with the fraternity. The motion was unanimously approved.

5. Youth Commission

Betti Longinotti, SFO, Youth/Young Adult Commission chair, showed a flyer about the Youth Congress to be held during the 2007 Quinquennial.

She is asking for support to send youth to the congress and asked the BSSF Region for up to \$1,000 for this effort. The youth selected will be asked to put down a deposit to show their interest in attending the congress. Deacon Dennis moved, and Audrey Binet, SFO, Area Three councilor, seconded the motion to approve this expenditure. The council voted unanimously to approve the motion.



This letter is to notify you that our Chapter of Elections will be held during the Annual Regional Gathering in Ridgecrest, N. C., Aug.10–12, 2007. A quorum of ministers and the voting members of the regional executive council or their delegates must be present for the regional fraternity council to elect a slate of officers.

Every established fraternity minister and the elected minister, vice minister, secretary, treasurer, formation director, and seven area councilors of the regional executive council are eligible to vote as members of the regional fraternity council. Eligible voters must be present or delegate this responsibility to another member. The delegate must have a document written by the minister stating that said person is a delegate and has been appointed to that position by the executive council. Without the written statement, the delegate does not have voting rights. The delegate must give the statement to the regional secretary <u>before</u> the annual regional fraternity council meeting.

Please submit nominations for minister, vice minister, secretary, treasurer, formation director, and area councilors. At this time there are seven area councilors. Members of your fraternity, emerging community, or newly forming group and the regional executive council members may nominate a member(s) of your fraternity, community, or group, or any fraternity, community, or group within the Brothers and Sisters of St. Francis Region. They may be nominated for more than one position. Nominees must be active professed members with proof of SFO profession. They can be members of established fraternities, emerging communities, or newly forming groups.

Fraternity ministers, emerging community leaders, and newly forming group leaders please review, with all members, "Article 5. Duties of Members of the Regional Executive Council" of the *Regional Guidelines* (page 14) and Section II: Voting and Conduct of Business—Articles No. 6 and No. 7 in the guidelines. In addition, peruse the "Election Chapter Nomination" form.

NOMINATION FORMS ARE DUE BEFORE JUNE 15, 2007.

Mail one copy of the nomination form [see page 16] to Joanne Babin, SFO, and one copy to Cathy Bohnsack, SFO. This duplicate mailing is to insure that all nomination forms are received. Once the nominations are received, the "Election Chapter Nomination" form will be sent to each nominee so that he or she will have the opportunity to accept or decline the nomination(s). This is why it is important that all nomination forms are received before June 15, 2007.

Guidelines of the Regional Fraternity, Brothers and Sisters of Saint Francis, Secular Franciscan Order

Article 5. Duties of Members of the Regional Executive Council

- 1. The **Regional Minister**, in addition to the duties set forth in article #63 of the *General Constitutions*, has the following duties:
 - a. To prepare with the regional treasurer and the regional secretary the annual report to the regional fraternity and to the national fraternity. The report to the regional fraternity will include the Fair Share Summary Report, the Treasurer's Report, and the Proposed Budget. It will be forwarded to the members of the Regional Fraternity Council after approval by the Regional Executive Council no later than one month prior to the annual meeting. The annual regional report to the national fraternity will include the requested fair share contribution, the Treasurers Report and updated information as requested.
 - b. To approve when necessary extraordinary (non-budgeted) expenditures, not to exceed one per cent (1%) of the annual regional budget.
- 2. The **Regional Vice Minister's** duties are enumerated in article #52.1 of the *General Constitutions*.
- 3. The **Regional Secretary**, in addition to the duties enumerated in article #52.2 of the *General Constitutions*, has the following duties:
 - a. To record the minutes of Regional Fraternity Council Meetings and distribute to the Regional Executive Council for review before the next scheduled Regional Executive Council Commissions Gathering.
 - b. To distribute the reviewed minutes of the Regional Fraternity Council Meetings within one month to the Regional Fraternity Council and the leaders of the newly forming groups and emerging communities and again at or before the next Regional Fraternity Council Meeting when the minutes will be approved.
 - c. To record the minutes of Regional Executive Council Gatherings and forward to the Regional Executive Council for review within one month.
 - d. To prepare a summary of the approved minutes of Regional Executive Council Gatherings and distribute to the Regional Fraternity Council and the leaders of the newly forming groups and emerging communities.
 - e. To furnish a copy of the approved minutes of Regional Executive Council Gatherings (excluding personal or sensitive matters) *when requested* by a local minister or leader.
 - f. To assist the regional minister and regional treasurer with the annual report to the regional fraternity and the national fraternity.
 - g. To assist in maintaining the national database as needed.
 - h. To perform such other duties that the Regional Fraternity Council, Regional Executive Council and Regional Minister may designate.
- 4. The **Regional Treasurer**, in addition to the duties enumerated in article #52.4 of the *General Constitutions* has the following duties:
 - a. To function in accordance with the Fraternity Internal Controls and Treasury Guidelines.


- b. To assist the regional minister and the regional secretary with the annual report to the regional fraternity and to the national fraternity.
- **c.** To make financial reports to the Regional Executive Council as requested.
- d. To contact and schedule a meeting with two qualified professed members that do not serve on the Regional Executive Council to review the treasury records every year before the Annual Regional Gathering.
- e. To send a copy of the approved budget to the region after the Annual Regional Gathering. This approved budget shall be published in the regional newsletter.
- f. To perform such other duties that the Regional Fraternity Council, the Regional Executive Council and the Regional Minister may designate.

5. The **Regional Formation Director** has the following duties:

- a. To assume the position of Regional Formation Commission Chair after being duly elected to the regional council.
- b. To involve the Regional Spiritual Assistant(s) in all formation including the development of formation programs.
- c. To direct the deliberations of the Regional Formation Commission and report such deliberations to the Regional Executive Council.
- d. To perform such other duties that the Regional Fraternity Council, Regional Executive Council and the Regional Minister may designate.

6. The **Regional Area Councilors** have the following duties:

- a. To serve on the Regional Formation Commission under the guidance of the Regional Formation Commission Chairperson.
- b. To visit fraternities and groups within their assigned area when formation guidance is requested or needed.
- c. To periodically contact all fraternities and groups within their assigned area no less than two times a year to encourage and discern if there are needs or problems.
- d. To preside and confirm the elections of local fraternities and conduct fraternal visitations of fraternities and groups within their assigned area when requested by the Regional Executive Council.
- e. To preside and confirm the elections of local fraternities and conduct fraternal visitations of fraternities and groups as a delegate to another area when requested by the Regional Executive Council.
- f. To attend admissions, professions, canonical establishment ceremonies and other special events within their assigned area whenever possible.
- g. To perform such other duties that the Regional Fraternity Council, Regional Executive Council and Regional Minister may designate.
- h. To refer to the *Handbook for Secular Franciscan Servant Leadership* and the *Handbook for Spiritual Assistance to the Secular Franciscan Order* (**revised 2005**) for further directives. **T**
