

Minister's Message

Why is community life necessary? Why must we get together so often? St. Francis had brothers and gave us the model to follow the Gospel.

Our Rule and Constitutions are our guides. Our brothers and sisters lift us up when we are down and we reach out when they need us. Our Rule calls us to "seek out ways of unity and fraternal harmony through dialogue, trusting in the presence of the divine seed in everyone" (Article 19).

We do not journey alone. We gather to pray together, to learn, to serve, and to grow as members within our particular spirituality and lifestyle.

Fraternity calls us to do things like speak the truth in love —the love of Christ and the spirit of Francis and Clare. We're encouraged to dialogue and brainstorm regarding each one's expectations, hopes, and vision for the fraternity.

We must sift among these pieces to find the common elements for the "good of the fraternity" rather than promoting our individual agendas.

Let us come together as fraternity and celebrate who we are. I hope you'll join us at our annual gathering, but continue to celebrate each other in local fraternity gatherings and activities. We are truly blessed to have each other.

From the Rule of the Secular Franciscan Order

Article 1. The Franciscan family, as one among many spiritual families raised up by the Holy Spirit in the Church, unites all members of the people of God — laity, religious, and priests — who recognize that they are called to follow Christ in the footsteps of St. Francis of Assisi. In various ways and forms but in life-giving union with each other, they intend to make present the charism of their common Seraphic Father in the life and mission of the Church.

Article 2. The Secular Franciscan Order holds a special place in this family circle. It is an organic union of all Catholic fraternities scattered throughout the world and open to every group of the faithful. In these fraternities the brothers and sisters, led by the Spirit, strive for perfect charity in their own secular state. By their profession they pledge themselves to live the gospel in the manner of St. Francis by means of this rule approved by the Church.

Article 19. Mindful that they are bearers of peace which must be built up unceasingly, they should seek out ways of unity and fraternal harmony through dialogue, trusting in the presence of the divine seed in everyone and in the transforming power of love and pardon.

Messengers of perfect joy in every circumstance, they should strive to bring joy and hope to others.

From the General Constitutions of the Secular Franciscan Order Article 26

2. In the fraternity, the brothers and sisters should promote mutual understanding and they should see to it that the atmosphere of their meetings is welcoming and that it reflects joy. They should encourage one another for the good.

Article 30

- 1. The brothers and sisters are co-responsible for the life of the fraternity to which they belong and for the SFO as the organic union of all fraternities throughout the world.
- **2.** The sense of co-responsibility of the members requires personal presence, witness, prayer, and active collaboration, in accordance with each one's situation and possible obligations for the animation of the fraternity.

Editor's Journal

We're focusing on fraternity at this year's ARG, and this Communio has so much about fraternity.

We have Father Linus's article on the value of fraternity apostolates, Sacred Hearts of Jesus and Mary Fraternity going out to help residents in another town, Father Kevin Queally urging us to look at just how co-responsible we feel about our fraternities, ways for our fraternities to implement JPIC (Justice, Peace, and Integrity of Creation), the Minister's Message reminding us of just how vital fraternity is to our growth in SFO life.

St. Francis lived community. When he preached, at least one other friar was with him. When he went to remote places to pray and contemplate, other friars were nearby.

Even Franciscan hermitages weren't for lone individuals. We might think of hermits as solitaries, but that wasn't Francis's concept. Hermits were to have solitude for prayer and contemplation, but other friars were there to minister to them and to make sure they had the privacy they needed.

In "A Rule for Hermitages," Francis wrote, "Let those who wish to stay in hermitages in a religious way be three brothers or, at the most, four; let two of these be 'the mother' and have two 'sons' or at least one. Let the two who are 'mothers' keep the life of Martha and the two 'sons' the life of Mary. ... The 'sons,' however, may periodically assume the role of the 'mothers,' taking turns for a time as they have mutually decided" (*St. Francis of Assisi, Early Documents, The Saint*, pp. 61–62).

The first time I went to Italy with St. Francis Pilgrimages, we visited the remains of Soffiano, a hermitage built in 1101, about three miles from the Convent of San Liberato, in a canyon in the Sibylline Mountains.

All that's left of Soffiano is one wall, which the friars maintain. It's built into a cave, and there's a simple stone altar. The holes in the wall and in the cave wall indicate where were the support beams that held the upper floors. At three stories high, it was too large a place for just one person.

We heard Chapters 47 and 46 from *The Little Flowers of St. Francis*, which tell of friars who lived at Soffiano (the friar in Chapter 47 is believed to have been Liberato).

Chapter 46 tells of Brother Pacifico and Brother Umile, who were not only brother friars but biological brothers, as well. They are united in a special way even though not living in the same place. Brother Umile died as Soffiano, and Brother Pacifico, "while praying in a solitary place, was rapt in ecstasy and saw the soul of his brother Umile ascending straight into heaven, without hesitation or obstacle, as it departed from the body."

Brother Enrico, a friar who was with us that day, said this story teaches us that we can't become holy until we learn to love one another. It's not just about me and God, he said. God loves each person, and that makes them worthy of our love. We don't become holy by ourselves but with one another. It takes a community intention and accepting our brothers and sisters. Forgiveness is the most important virtue in achieving this.

Co-responsibility, personal presence

While reading *Pick More Daisies* by Father Lester Bach, OFM Cap., I came across two paragraphs from the General Constitution of the SFO, which caused me to reflect on and, indeed, go to the Constitutions! I have included a third paragraph from the Constitutions, one that is in close proximity to the others.

"The brothers and sisters are coresponsible for the life of the fraternity to which they belong and for the SFO as the organic union of all fraternities throughout the world" (GC, Article 30. 1). This is quite an article. Imagine! All of the members are co-responsible for the life of the fraternity, not only on the local level, but also on the regional, national, and international level!

This is something we must think about and examine ourselves about. Are we really involved in the fraternity so much so that we feel co-responsible? What about our region? It is tempting to think that service to the fraternity, as a leader, is an option. No, it is not. We are all co-responsible!

The life of the local fraternity is extremely important, but it is not the only part of the Order. Each member has brothers and sisters in the SFO all over the United States and, indeed, all over the world. The members are connected by a common Rule and spirituality. How developed is that concept and reality in my local fraternity? This must be asked, and each fraternity should be finding ways to express this interconnectedness.

"The sense of co-responsibility of the members requires personal presence, witness, prayer, and active collaboration, in accordance with each one's situation and possible obligations for animation of the fraternity" (GC, Article 30. 2).

In another article by Father Lester, the Seculars are called to DO something. He



emphasizes "personal presence." The fraternity is not the fraternity without you there. In addition, for active collaboration, you must not only be here, you must collaborate — work with others! The fraternity depends on each and every one.

You are a Franciscan. Your life must reflect this call, this vocation: witness. It is fairly impossible to do it for one hour a month. That would be like eating only once a month. For instance, prayer is something we do each day. Our witness and our prayer are linked organically. There cannot be one, authentically, without the other. The SFO is not a contemplative Order. There must be action and contemplation!

The personal presence is essential to build your community. One hour a month is the very least you can give. Perhaps you already know that the burdens of being minister are great. Do you offer to help? Do you jump at the chance to volunteer to organize an event? In what way do you work with other fraternity members so the burden is lighter for all? We must all animate the fraternity, whether it is on the local, regional, national, or international level! It calls on us to give of ourselves.

"The leaders should see to the spiritual and technical preparation and animation of the meetings, both of the fraternities and of the councils. They should seek to inspire life and soul into the fraternities by their own

witness, suggesting appropriate means for the development of the life of the fraternity and of apostolic activities in the light of the fundamental Franciscan options. They should see to it that the decisions made are carried out and they should promote collaboration among the brothers and sisters" (GC, Article 31. 4).

While this article does address the leaders, please remember what was said earlier about co-responsibility. We all help decide the appropriate activities to be developed for the fraternity, both on the spiritual and apostolic side. (This includes spiritual assistants!)

The General Constitution says: "They should seek to inspire life and soul into the fraternities." This is quite a tall order. Perhaps many are daunted by the idea of leadership. Too often at elections, it is difficult to find fraternity members to serve in all the positions. Our documents do not allow the same person to serve over and over. There are "term limits." We are all called to serve. None of us should feel we are in it alone. We are able to call on the whole fraternity to help in the responsibilities.

As I reflected on these articles of the General Constitutions, I was reminded that these ideals are something that we need to bring to mind and strive toward. It is difficult for us to be doing well in all areas of our Franciscan life. It almost never happens. We are human beings. Only God is perfect. But the key is to keep striving, keep trying, and continue being active. The Rule is something for SFOs to work at their whole lives.

Many, I fear, are not familiar with our documents. Some are too familiar and get lost in legalism. For all, the admonition is to live the Rule, bring it to life in your own home and workplace and neighborhood and parish. To borrow from the popular saying, you are the only Franciscan many will ever meet.

Our Franciscan life constantly challenges us to grow. Remember St.

Francis saying, "Let us begin, for up to now we have done very little." This was at the end of his life! We can grow and change and constantly become better Franciscans! **T**



Spiritual assistant course concludes with retreat

"The Spirit is moving us into this era of lay spiritual assistants," said Father Linus DeSantis, OFM Conv., BSSF Region spiritual assistant, during the retreat he led June 19–21 at Living Waters Catholic Reflection Center in Maggie Valley, N.C.

"You've been called to this by the Lord," Father Linus said. "It's a matter of surrender: 'Speak, Lord, your servant is listening."

The retreat wrapped up a program in which we spent a year studying and praying as we prepared for a new ministry. A commissioning is scheduled to take place during the Annual Regional Gathering.

Sixteen SFOs began the course, but several were unable to finish because of work schedules and other commitments.

Eleven of us completed the program and attended the retreat:

The Conference of National Spiritual Assistants developed Franciscan Family Connections, the name of both the program and its textbook. The CNSA is a group of four friars, one from each of the obediences. The CNSA members who developed the program were Father Lester Bach, OFM Cap.; Brother Bob Brady, OFM; Father Bart Karwacki, OFM Conv.; and Father Kevin Queally, TOR.

We discussed most chapters in class sessions with Father Linus, in accordance with the program recommendation for periodic student meetings.

Franciscan Family Connections notes that the CNSA "strongly urges applicants (from a proximate geographic area) to gather regularly (with the mentor) to share ideas and insights. Common sessions help people to know one another while deepening their understanding of the role of spiritual assistant" (from the Introduction).

We met six times, starting in March of last year. Gatherings were at Belmont, N.C. (twice); the 2008 Annual Regional Gathering; at Athens and Jonesboro, Ga.; and for the retreat in Maggie Valley. Since several students serve on the Regional Executive Council, class sessions usually coincided with REC meetings. At each session we covered one or two chapters of *Franciscan Family Connections*.

Topics included the spiritual assistant's role, Franciscan theology and spirituality, the Trinity, initial and ongoing formation, Franciscan writers such as St. Bonaventure and John Duns Scotus, See SPIRITUAL, page 9

Vatican II, SFO organizational structure, the Ritual and devotions, and Church and Eucharist. So, what's next?

At this writing, Father Linus and the REC haven't yet determined where we'll serve. As *Franciscan Family Connections* notes, "CNSA recommends that ordinarily SFO members not be appointed to serve their own fraternity. However, there are times when pastoral considerations may make this necessary. Please realize that an SFO spiritual assistant does not vote in elections or on economic issues" (p. iii).

A spiritual assistant is a member of the council of the fraternity he or she serves. Although we'll continue to participate in the activities of our home fraternities, Father Linus recommended that we not serve on the councils in our own fraternities. It's important, he said, that as we help to feed those in the fraternities in which we minister as spiritual assistants, we allow ourselves to step back to be fed in our home fraternities.

On Saturday morning, Sister Bernadette Marie Cappola, OSC, from the Poor Clare monastery near Travelers Rest, S.C., joined us, as she's interested in spiritual assistant work. She offered to compile a list of books and other materials related to Franciscan life and spirituality.

During the retreat, we reflected as a group on what we had learned and what might be our futures as spiritual assistants. We agreed that getting together was invaluable and that we need to keep in touch. **T**

Going the extra mile: Fraternity treks to housecleaning apostolate

Barbara Elkins and Daly Guiterrez, inquirers; Dan Cronin, SFO, candidate; Joe Bailey, SFO; Maureen Cronin, SFO; Rhoda Haight, SFO; Judy Haupt, SFO; and I helped in the SugarHill/Flatt Street Community.

We mowed, raked, and cleaned the yard; painted rooms, cleaned windows, and power washed a home chosen by Lottie Lewis, community coordinator. The three residents were truly grateful for our help and were quite astonished that we had traveled so far to come to help them.

The fraternity became aware of needs in Allendale after reading an article in the Diocese of Charleston's newspaper, The Catholic Miscellany. The paper had reported how the Franciscan Center on St. Helena Island sponsors community gardens and other programs there.

Franciscan Sisters Sheila Byrne and Stella Breen have run the Franciscan Center for more than 20 years; it is well known in Beaufort County for its outreach to immigrants and the needy.

George Bellas, SFO, our treasurer, brought the article to the fraternity council, which chose to donate funds for garden tools, seeds, and supplies. The sisters were thrilled to have the local Secular Franciscans "partner" with them in to help Allendale.

One Saturday in March, the sisters and I went to Allendale to see the community gardens and meet with the coordinator there. And a new "seed" was planted — to offer our help to their community at a future date, on a fifth Saturday. **T**

The Spirit is free with her call. None of us can say we deserve it. We can only be thankful that we received it. With that call comes the responsibility for a total embrace of the spirit of St. Francis. It requires a lifelong openness to personal growth in understanding more fully, and embracing with greater commitment, this special call.

Theological reflections after fraternity apostolic experiences

You may be familiar with the story of Brother Leo and St. Francis when St. Francis invited Brother Leo to accompany him on a journey.



On this journey Francis was to preach. Brother Leo was delighted.

As they went through the town Brother Leo waited with great anticipation.

They came to the other end of town. Francis had not preached. Haltingly, Brother Leo asked Father Francis why he hadn't preached.

Father Francis said, "Oh but, Brother Leo, we did. As we met and greeted the people of the town, we shared our love and the peace of Christ. As we walked in harmony sharing our joy and praising God — we preached."

So, my sisters and brothers, it is not always in what we do, but how we do it. Apostolic life for a Franciscan lies more in the cooperation, sharing and participation than in the act of doing.

Not to minimize acts of charity, but the Franciscan formula highlights the shared approach. So the preferred is that a community adopt an apostolic activity or activities in which the members can participate with their brothers and sisters in some creative way.

This visible activity to make a difference in the world will attract people to the fraternity or group and the Secular Franciscan Order. Others will see how you as a Franciscan community minister together.

Practical Application:

Provide a time of "theological reflection" — verbal or written — after each apostolic experience. Suggestion: Select perhaps three questions to reflect upon after an apostolic experience. The next experience, you might reflect upon three different questions.

- ➤ What was done?
- ➤ What was the benefit of the experience?
- ➤ What was the result for those served and for you?
- ➤ What was the "feeling" in the giving?
- ➤ How was your service received?
- ➤ How were you present to the experience?
- ➤ How was Christ present?
- ➤ How did you minister to Christ?
- ➤ How did you, as Francis, receive the Christ and share the Christ?
- ➤ Did others see you as a Franciscan community ministering together?

- Was the community sensitive to the gifts and temperaments of its members?
- Are you coming to know each other at a deeper level?
- Are you sharing values, telling your story, telling about your relationships, and working with others?
- ➤ Did you cooperate, share, truly listen, embrace change, respect the other, and appreciate the person and the task?
- > Did you communicate individuals working as a unit in peace and harmony?
- ➤ Was there mutual cooperation among the members?
- ➤ Was there sincere respect among the members?
- ➤ Was there generous sharing and energy expended?
- What was the experience in working and sharing the task with the other members?
- ➤ How were you, as Francis, one with your brothers and sisters? **T**

Called to follow Christ

Called to Follow Christ is one of the books written by Father Benet Fonck, OFM. It is a commentary on our Rule and most helpful during a fraternity dialogue about the articles of our Rule.

In an effort to take away the best understanding as to how each article is meant to be understood, our fraternity uses it as a resource.

At our June fraternity gathering, our members dialogued about Article 8 of our Rule:

"As Jesus was the true worshipper of the Father, so let prayer and contemplation (element of Franciscan spirituality) be the soul of all they are and do.

"Let them participate in the sacramental life of the Church, above all the Eucharist. Let them join in liturgical prayer in one of the forms proposed by the Church, reliving the mysteries of the life of Christ."

Our dialogue brought us to the following understanding, about which Father Fonck writes so beautifully on pages 41–48 of his book:

"Prayer as an essential element of our Franciscan way of life puts us in intimate communication with God, puts us in touch with our own identity, and gives us the energy, strength, and determination to live the gospel more effectively.

"Francis' life shows that prayer, as an experience and expression of intimate faith, is not just a dream or an ideal, but something very real, very attainable. When we survey the texts written by and about Francis on his relationship with God, we readily see his preoccupation with making God's presence unfold in community and be inserted into the world. The heart of his life's project was to meet and recognize the Lord.

"Francis definitely knew the Father through the Son in the Holy Spirit, and he honestly and confidently could say, 'The Lord inspired me.' 'The Lord gave me,' etc. because this truly happened.

"That exciting, overpowering personal awareness of Francis that the Lord had touched his heart and was active and present in individuals as well as in community, brought him to such depth of being at one with the Lord that his intensely personal, deeply intimate union with God

became the source, the goal, and the energy of his whole life."

Suggested reflections at the end of the chapter: 1) Have you been conscious of



JPIC invites SFOs to reach out — together

Secular Franciscans, together with all people of good will, are called to build a more fraternal and evangelical world so that the kingdom of God may be brought about more effectively. Mindful that anyone "who follows Christ, the perfect man, becomes more of a man himself," let them exercise their responsibilities competently in Christian spirit of service (SFO Rule, Article 14).

Each fraternity has at least one apostolate and is making a difference in its community. When we join forces, we can accomplish even more.



"I've received e-mails stating that while waiting for JPIC to put together 'a program,' people are homeless, starving, suffering, etc.," Pat Brandwein-Ball, SFO, JPIC transition chair, wrote in this summer's issue of TAU-USA. "JPIC is an invitation to a mature understanding and authentic living of our Rule, with enthusiasm and gusto! ... As Franciscans, living in the secular world, we must realize (make real) our way of life."

She went on to write: "JPIC contact information was requested from each Regional Minister. Twenty of the 30 responded. Some had no one appointed and had questions, but nonetheless, 20 responded."

Here's what Rob Breen, SFO, JPIC chair for the Blessed Kateri Tekakwitha Region (upstate New York & Western Pennsylvania), envisions:

In relation to JPIC commissions, I think it is crucial for us to get away from the "information dump" roles that have been traditionally played.

Some chairs simply get on several e-mail lists and forward them to all their fraternity members. This is not effective at mobilizing Franciscans to apostolic action. We simply get

inundated and overwhelmed with information. Something more strategic and Franciscan needs tobe created. For example:

- **1.** Form a committee (or two) to focus on particular issues (poverty and environment, for example).
- **2.** Focus initially on developing a literacy of Catholic and Franciscan approaches to the issues. This is a focused formation period, and everyone in the fraternity can be involved. Keep in mind that we Franciscans often act our way into thinking (not vice versa), so "formation" can involve participating in a local poverty or conservation service project and then reflecting on the experience and learning about the related issues.
- **3.** Study the local issues. Rain Forests in South America are neat, and we should be concerned about them, but there are important local and regional issues that need to be addressed, too. When problems get too abstract or distant, they can cease to be a mobilizing experience for our SFO fraternities. (There are other agencies that are better equipped to address international environmental and social justice issues.)

In our area, we have pollution in our Hudson River that is impacting human health, and flooding brings PCBs and other toxics into the backyard of poor and working-class neighborhoods. Fraternity members can walk to these places, talk to the people affected, touch the grass and trees, hear the birds chirping, touch the leaves, and canoe on the water.

4. Adopt an issue or two and get to work. Pull in outside speakers, specialists, or experts to talk about the issues, and set up some hands-on projects to start making a difference. Simple projects, like tree planting, lead testing in homes, community gardening, etc., can quickly engage SFOs in helpful ministries.

There need to be ongoing formation opportunities, too, to help SFOs understand our own Franciscan tradition, and to allow ongoing and daily conversion as we enter more deeply into relationship with God's Creation and God's poor people. Focus on our Rule, which calls us to be Franciscan in this way.

5. We also need to find ways to collaborate with fraternities throughout the region, and with neighboring regions, sharing our stories and Franciscan ministries.

We can create interregional conferences on Franciscan JPIC, perhaps in collaboration with friars and Franciscan sisters. Regional fraternities from the Northeast (or Southeast or Midwest or the West, etc.) could gather annually. Or at the annual meeting, perhaps we turn them more into mini-conferences, to include formation activities, strategic discussions about apostolic Franciscan ministries, service project experiences, dynamic liturgies that "commission" SFOs in JPIC ministries to go out into the world to be the Good News.

Certainly "tagging along" with other Franciscan family conferences (or even having a Franciscan presence at a secular social justice or environmental conference, in the same way that we host Franciscan Youth (YouFra gatherings at World Youth Day) keeps the logistical problems and cost issues reasonable.

6. At nearly every peace, justice, and environmental event, there should be SFO/Franciscan faces (and hands) and discreet Taus letting everyone know that SFOs are present and engaged.

- **7.** We need to come together at regional and national levels to develop a funding and development strategy to support these SFO JPIC ministries. We are developing just such a strategy in our region.
- **8.** We also need to develop effective SFO JPIC leadership that can mobilize SFOs to contemplative action.
- **9.** Keep remembering that we are the Secular Franciscan Order, that we made a lifelong commitment to a Franciscan life, and that we professed to live out the SFO Rule. We have obligations to live out the call of the Holy Spirit, and to be the presence of Christ in the world. We have vocations to walk in the footsteps of Francis and Clare to do the gospel life according to the little way." **T**

Treasurer's report to the BSSF Region Council to be presented, Aug. 8, at the 2009 Annual Regional Gathering

Since we are at the midyear point in the work of the region, it is only proper that we reflect on the actual results of calendar year 2008, the projections for calendar year 2009, and the forecast for calendar year 2010.

I am pleased to report that we ended calendar year 2008 with a balanced budget. In actuality we had a positive \$305.76 for the year on income and expenses of nearly \$21,000 each.

Thus far in 2009, although we forecasted a sizable deficit, we have managed to maintain control on expenses and anticipate exceeding our income projection. Therefore, we are optimistic that we should close this calendar year with a balanced budget, as well.

The 2010 calendar year budget (see page 18) reflects forecasted expenses and income of \$24,080 each. If we are able to meet this forecast we will once again operate under a balanced

budget. This would represent four years in a row of fiscal responsibility by your regional council. One major change in the 2010 budget reflects a different approach to accounting for fraternal and pastoral visitation and election expenses. This is a change that we began implementing in 2009.

We are now requesting that all executive-council members submit actual expenses for their service to the region during visitations and elections.

Furthermore, we request that stipends provided by the fraternities to fraternal visitors be made payable to the BSSF Region. This procedure allows us to more accurately reflect the true cost of serving the region.

I will be happy to answer any questions or concerns regarding the 2010 budget or related topics. ${\bf T}$

The new formators' guidelines will include a document called "Twelve Elements of Franciscan Spirituality. One of those is "Communal Life":

Francis recognized that we are all brothers and sisters and that we need one another.

A hallmark of the Franciscan Order is the communal life. He believed that God had sent the men who came to follow him and so he would not refuse any of them entrance into the community.

He told his friars, "If a mother loves her child how much more should spiritual brothers and sisters love and help one another." Francis believed that Gospel living was communal living. He wanted his friars to live a common life which reflected the life of the early Christian depicted in the Acts of the Apostles.

"The community of believers was of one heart and mind, and no one claimed that any of his possessions was his own, but they had everything in common" (Acts 4:32).

Franciscan Spirituality is characterized by a love for community. Francis would encourage us to build caring communities. During his life he tried to recreate the warm, compassionate, loving communities of the early Church and he invites us to do the same.

This aspect of Franciscan Spirituality calls us to love one another as brothers and sisters and to promote friendship and community with all people. It calls us to set aside prejudice and hatred and to be family with one another.

What attitude(s) or disposition(s) could I embrace to improve the quality of life in my community?
